Dear Honorable Judge Keith Meyer

I learned yesterday that the Loulourgas family has filed a complaint with your court under the above file number. We were very surprised to learn this, as the complaint was served by Phelps, the legal representative, at an address that was incorrect. We only became aware of the lawsuit by chance.

The legal representative as well as the Loulourgas family know the addresses of our offices in NYC, in Switzerland and me privately. Why the lawsuit was served on an unknown address that is not responsible for us, I cannot say.

In addition, I am enclosing a testimony of my psychiatrist who is taking care of me. The psychic pain that I have suffered as a result of the "ATM-Loulourgas" case is so severe that I have not been able to work for months. In addition, my psychiatrist has certified - see doctor's certificate - that I am neither fit to be questioned nor to stand trial and therefore cannot participate in a court hearing until further notice. In a consultation with the psychiatrist, he has confirmed that this certificate will be extended again after the end of March 2023 until the end of June 2023.

Therefore, I ask you to reschedule the court hearing because:

- 1. we have not been served with the complaint until now
- 2. I am unable to attend a hearing for health reasons (psychological stress disorder caused by the "ATM-Loulourgas" case).

I am sending this letter to you in advance by mail to the court clerk and at the same time by Fedex. In addition, a capy will go to counsel Phelps and to the plaintiffs themselves.
